Engineer Reese said the plan is pretty clean and has no major concerns. Engineer Reese said the NPDES is adequate. He said the retaining wall shown on LD4 is still in steep slope and a variance would need to be requested. Todd Lyons said there is disturbance occurring in steep slope. Engineer Diffenbaugh said the retaining wall could be wrapped around to not be in steep slope area. The PC board agreed if this were done there would be no need for a variance.

**A motion** was made by Todd Lyons to recommend approval of the plan contingent upon changing the design of the retaining wall to keep it out of steep slope, a review letter and any outstanding review by government agencies.

Second by Vice Chairman Wenrich.

**Discussion:** there was no further discussion.
